

The OWASP SAMM™
(Software Assurance Maturity Model) is a community-led open-sourced framework that allows teams and developers to assess, formulate, and implement strategies for better security which can be easily integrated into an existing organizational Software Development Life Cycle (SDLC).

Shift Left:

Security must be integrated in all phases of the software development lifecycle.

A **SAMM roadmap** has the benefit of making security maturity in the Software Development Life Cycle measurable, comparable and actionable. The current position can be compared to future and past levels, as well as with competitors or benchmarks.
